

SOUTH GLOUCESTERSHIRE COUNCIL
(Various Road, Various Wards, Surface Dressing and Carriageway Patching)
(Temporary Prohibition of Use by Vehicles, Foot Passengers, Pedal Cycles and
Equestrians) Order 2023

Notice is hereby given that South Gloucestershire District Council in pursuance of the provisions of section 14 of the Road Traffic Regulation Act 1984 as amended intends to make an order the effect of which will be to close, temporarily, to vehicles, foot passengers, pedal cycles and equestrians the roads and lengths of road specified in Schedule 1 to this notice.

This order is required for the following reason: in connection with the likelihood of danger to the public consequent upon surface dressing and carriageway patching works. The order will be operative from 20 September 2023 for a maximum period of eighteen months. The closure however may not be implemented for the whole of the period but only when traffic signs are in position and only for so long as is necessitated by the works which are anticipated to be of a **1 week** duration, at each location in respect of each road or length of road. For alternative routes see Schedule 2.
