On inspection the fence panels were badly damaged and in need of replacement to secure the property garden.</p> <p>Parish Clerk wanted Council to ensure they don’t set a precedent by replacing property owned privately as many property gardens back on to land owned by the Parish. The Clerk mentioned we may have fence panels and materials in store.</p> <p>Following discussion Councillor Ernie Brown proposed to provide four fence panels and posts to the local resident as a gesture of good will, seconded by Councillor Mike Brown, carried.</p> <p>New road names suggestions for development East of Harry Stoke.</p> <p>The Parish Clerk has received correspondence from South Gloucestershire Council where they have asked the Parish Councillors to help suggest suitable street names for this development.</p> <p>Councillors have come up with the following recommendations which the Clerk will pass to SGC.</p>
