



## DATA PROTECTION PRIVACY POLICY

Stoke Gifford Parish Council regard your privacy as important towards complying with the Data Protection Act 1998 and the General Data Protection Regulation (GDPR).

We process and hold information to provide public services. This notice explains how we use and share your information. Information may be collected on a paper or online form, by telephone, email or by a member of our staffing team, or one of our statutory partners.

### WE RECORD PERSONAL INFORMATION IF YOU:

---

- Subscribe to or apply for services that require personal information.
- Report a fault and give your contact details for us to respond
- Contact us and leave your details for us to respond

---

### WHY WE COLLECT INFORMATION

---

We collect and hold information about you, to:

- Deliver public services
- Confirm your identity to provide some services
- Contact you by post, email or telephone
- Understand your needs to provide the services that you request
- Understand what we can do for you and inform you of other relevant services and benefits
- Obtain your opinion about our services
- Update your customer contact records
- Help us to build up a picture of how we are performing at delivering services
- Allow us to undertake statutory functions efficiently and effectively
- Make sure we meet our statutory obligations

---

### OUR RIGHTS TO PROCESS INFORMATION

---

We are permitted to process information under GDPR Article 6 (1) (a) (b) and (e) when:

- Processing is with consent of the data subject, or
- Processing is necessary for compliance with a legal obligation, or
- Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller

---

### HOW WE USE YOUR INFORMATION

---

We will only use any personal information you send us for the purposes for which you provide it. We will only hold your information for as long as necessary. All employees who have access to your personal data and are associated with the handling of that data information are obliged to respect the confidentiality of your data information. All your communications to us are protected against unauthorised access by third parties.

The Council tries to keep the information we have about you accurate and up to date. If, however, you find errors or inaccuracies in your data, we will erase, complete or amend that information upon request. Our contact details are at the bottom of this document

## **WE WILL PROCESS YOUR INFORMATION FOR THE FOLLOWING PURPOSES:**

---

- For the service you requested, and to monitor and improve the council's performance in responding to your request
- To allow us to be able to communicate and provide services and benefits appropriate to your needs
- To ensure that we meet our legal obligations
- Where necessary for the law enforcement functions
- To process relevant financial transactions including grants and payments for goods and services supplied to the Council
- Where necessary to protect individuals from harm or injury
- To allow the statistical analysis of data so we can plan the provision of services

---

## **INFORMATION SHARING**

---

We may need to pass your information to other people and organisations that provide the service. These providers are obliged to keep your details securely and use them only to fulfil your request. If we wish to pass your sensitive or confidential information onto a third party, we will only do so once we have obtained your consent, unless we are legally required to do so. We may disclose information to other partners where it is necessary, either to comply with a legal obligation, or where permitted under the Data protection Act.

Where we need to disclose sensitive or confidential information to other statutory partners, we will do so only with your prior explicit consent or where we are legally required to. We may disclose information when necessary to prevent risk of harm to an individual.

## **INFORMATION SECURITY**

---

Stoke Gifford Parish Council cares to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and appropriate policies. We will only keep your data for the purpose it was collected for and only for as long as is necessary. After which it will be deleted in line with current legislation.

---

## **CHILDREN**

---

We will not process any data relating to a child (under 13) without the express parental/guardian consent of the child concerned.

---

## **YOUR RIGHTS**

---

**Access to Information:** You have the right to request access to the information we have about you. You can do this by contacting the Parish Clerk.

**Information Correction:** If you believe that the information we have about you is incorrect, you may contact us so that we can update it and keep your data accurate by contacting the Parish Clerk.

**Information Deletion:** If you wish Stoke Gifford Parish Council to delete the information about you please contact the Parish Clerk.



**Right to Object:** If you believe that your data is not being processed for the process it has been collected for, you may object by contacting the Parish Clerk.

**Rights Related to Automated Decision Making and Profiling:** Stoke Gifford Parish Council does not use automated decision making or profiling of individual personal data.

---

## IN SUMMARY

In accordance with the law, we only collect a limited amount of information about you that is necessary for correspondence, information and service provision. We do not use profiling, we do not sell your data, we do not pass your data to third parties without your consent.

We do not use your data for purposes other than those specified. We make sure your data is stored securely. We delete all information deemed to be no longer necessary and will continually review legislation to protect data information.
